#### 4. Student Care Financial Scheme (SCFA)

- 2) Child is a Singapore citizen. If the child is a PR, at least 1 member of immediate family is Singapore citizen.

Pro-Teach is an independent Student Care operator who does not receive any funding from the Government. Parents who receive student care fee subsidies from MSF are required to duly pay the co-payment fees.
